**AIR CONSENT ORDER (RENEWAL)**




Puducherry, the 12/

Consent is hereby renewed under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and orders made thereunder to **M/s. Pondicherry Institute of Medical Sciences** at Kalapet, Oulgaret Municipality, Puducherry authorising them to operate their plant in the Air Pollution Control area as notified subject to the conditions mentioned below:

- I. **Notwithstanding anything contained in any other Act or Rules or Notifications, this Consent is given from pollution angle only.**
- II. Consent is valid upto : 31.05.2020
- III. Manufacturing Products : Health Care Facilities
- IV. (i) Size : Large (iii) Location : Mixed  
(ii) Category : Red (iv) Area : 32 acres
- V. **Specific Conditions:**
  1. The ambient air quality at the boundary of the unit shall not exceed the following standards:-
 

PM <sub>10</sub>	-	100	µg/m <sup>3</sup>
SO <sub>2</sub>	-	80	"
NO <sub>x</sub>	-	80	"
CO	-	2000	"
  2. The noise level at the boundary shall not exceed 65 and 55 dB(A) during day / night times respectively. The industry shall comply with Noise Pollution (Regulation and Control) Rules, 2000.
- VI. **Implementation conditions:**
  1. The solid waste generated shall be properly segregated and collected in separate 'bins', green bins for biodegradable waste, blue bins for recyclable waste and black bins for non-recyclable waste as per Municipal Solid Waste Management Rules, 2016 and handed over to Municipality.
  2. The Project agency should obtain authorization under Bio-medical Waste Management Rules, 2016 and strictly abide by the provision for treatment and disposal of biomedical wastes without giving room for any violation.
  3. The provisions of Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 shall be strictly complied with.
  4. The 1 x 500 KVA and 1 x 750 KVA DG Sets shall be operated during power failure only and shall have Type Approval Certificate issued by agencies authorized by Central Pollution Control Board. DG Sets shall meet the noise and air emission standards prescribed under The Environment (Protection) Rules, 1986 and shall be provided with integral acoustic enclosure.
  5. The applicant shall comply with order of Hon'ble National Green Tribunal dated 11.05.2015 and implement all conditions in the CPCB Guidelines for DG Set. The DG set which are 15 years old or completed 50,000 Hours of Operation shall not be used.

6. The unit shall provide minimum stack height (H) to the DG sets as per the formula  $H = h + 0.2 \text{ SQRT}(KVA)$  where KVA= total generation capacity and h= Height of the building where DG set is installed.

**VII. General Conditions:**

1. Puducherry Pollution Control Committee reserves the right to review any condition imposed in this consent from time to time and modify, **review or revoke** or stipulate additional ones as per the provisions of Section 21(4) the Air (Prevention and Control of Pollution) Act, 1981 and to cancel this consent if any of the conditions is violated or any public complaint is received.
2. This consent order shall be exhibited in the office room and must be made available to the inspecting officers of this Committee.
3. The above conditions shall be enforced under the provisions of the Air (Prevention and Control of Pollution) Act, 1981; and the Environment (Protection) Act, 1986 along with their amendments from time to time.
4. The hospital shall maintain good house keeping in and around the hospital.
5. The hospital shall get prior consent from this authority before installation of any new D.G set or replacement of DG set


**VIII. Consent Validity & Report Submission:**

1. The applicant shall apply for renewal of this consent in prescribed format 30 days before expiry of this consent order.
2. The applicant shall apply in prescribed format for consent to establish if there is any expansion, change of activity, additional activity, change of modernization, diversification or change of location of the unit.
3. The unit shall submit an **Environment Statement** for the financial year ending 31<sup>st</sup> March in Form V prescribed under The Environment (Protection) Rules, 1986, on or before the 30<sup>th</sup> day of September every year.

**IX. Better Environmental Management Practices:**

1. Plantation of trees shall be done as per approved layout plan and the report shall be submitted to this Office after a year.
2. Energy conservation measures like installation of energy efficiency lighting like LED for lighting the areas inside and outside the building should be integral part of the design. Used CFLs and TFLs should be properly collected and disposed off/sent for recycling as per the prevailing guidelines/rules of the regulatory authority to avoid toxic contamination.
3. Appropriate Rain Water Harvesting Structures shall be established on scientific basis.
